Temporary Repairs / Roofing:

Issues: 15818 Pacher Creek Dr. Jax FL, FL 32218

Two large wind-damaged sections of this 3-tab roof needed temporary repairs on 5/28/24.

Process/Possible Cause:

Inspected roof and advised to tarp/cover two holes immediately. Homeowner waited to call carrier before approving temp-repairs so two trips were made to repair two sets of issues from storm dated 5/10/24

Section A:

Damages: On rear slope close to ridge shingles missing with damaged synthetic felt underlayment showing.

Temp Repair/s: Peel-n-stick underlayment applied over existing damaged underlayment and stuck down.

Existing 3-tab shingles that were blow on the ground & some re-attached using cap-nails.

Section B:

Damages: Same slope Damaged 3-Tab shingles exposing damaged underlayment and missing nails.

Temp Repair/s: Existing 3-tab shingles were temporarily re-nailed using roofing cap nails & adhesive.
